ADVOCACY

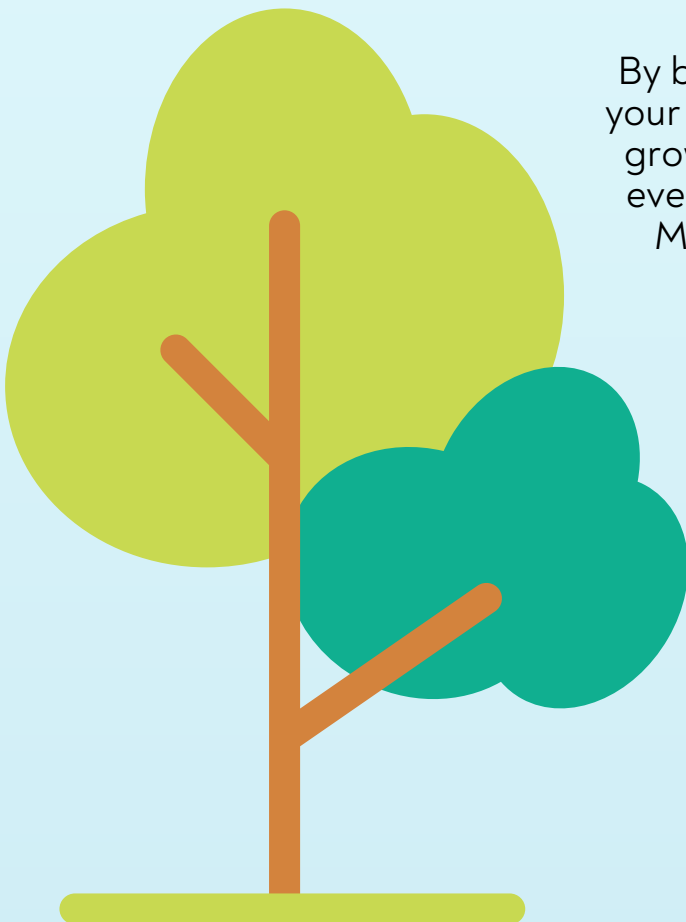
We advocate for all of our Chamber members by being a voice for them with local and state officials and community.
